### APPROVAL OF THE AGENDA

### APPROVAL OF CONSENT AGENDA

Director Dexter made a motion to approve the consent agenda. Vice President Teals seconded the motion. The motion carried unanimously. President Bailey abstained from voting on anything related to Basin Property Management, Inc.

- MLIRD Staff Beth Yonko handed out notices for the three Board of Director positions that are now open.
- The equalization hearing will take place on November 12, 2024 at 5:00 PM. The advertisements for the hearing will be ran on 10/21/24, 10/28/24, and 11/4/24.
- MLIRD will post for the candidacy of the three open Board of Director positions on Friday, October 18, 2024 in three public places.
- The MLIRD office has received three land petitions for consideration. The three petitions are for Donald & Carolyn Rogers Parcel #111885249, Carey & Nicole Tabert Parcel #311647000, and Michael & Rebecca Townsend Parcel #091187019. Michael & Rebecca Townsend were included in the last Resolution 2024-004. However, the parcel number was listed incorrectly and as a result, will be included in the new upcoming resolution. Director Dexter made a motion to accept the three land petitions for Donald & Carolyn Rogers Parcel #111885249, Carey & Nicole Tabert Parcel #311647000, and Michael & Rebecca Townsend Parcel #091187019 and move the

process forward. Director Ketterer seconded the motion. The motion carried unanimously.

 Doug Coutts with the City of Moses Lake Parks and Recreation Department and General Manager Sam Castro have been working on an interlocal agreement for the Moses Lake Fountain. Once the City of Moses Lake has approved and signed the agreement, General Manager Sam Castro will sign it.

#### RESOLUTIONS

Resolution 2024-005 Establishing Refunds to Correct or Rectify District Assessment Errors

This resolution authorizes the Moses Lake Irrigation and Rehabilitation District General Manager to correct all known errors, including refunds to correct or rectify errors. This includes double billing, parcels below high water, deemed unbuildable, having water certificates for irrigation, and other such anomalies.
